Denny reported he talked to Bill Vankirk and there would not be any increase in the towns insurance for the Distillery to go in with Creek Bottom Brew. Denny will let them know they can go ahead with the state.

Bill reported he was still having issues with the parking around the municipal building when the Creek Bottom is open. Denny will contact them to be more aware of their customer parking, police will start ticketing otherwise.


Jeff reported that a section of piping needed to be replaced on water street before the CCMG is started. Board will let contractor know.

After discussion about references given by Global, Greg made a motion to go with Global. Denny and Dave seconded. Kevin will get the contract ready and forward it to Global to be signed and then will send it to the town. Denny requested for the council to be able to attend the pre construction meeting. Council also informed Kevin that the utility needed to replace a small section of pipe on water street before they started.
